At the most recent joint meeting of the Town Council and the Occoquan Strategic Planning Committee, the group reviewed the four "Strategic Goals" developed by the Committee, and adopted them with slight modifications. They are:

- 1. Be the shopping, dining and entertainment hub of the Occoquan region, the pre mier leisure destination in Prince William, southern Fairfax, and northern Stafford counties.
- 2. Be an attractive center of employment for start-ups and small businesses (fewer than 25 employees) in targeted sectors.
- 3. Be regarded as one of the top 5 most attractive towns in Virginia.
- 4. Be clean, green, safe, and stable

Did You Know....

Outdoor Merchandise Displays

Outdoor merchandise displays are allowed in the Historic District but there are parameters which should be followed. Merchandise is to be displayed only during business hours and must be stored inside when the business is closed.

One of the most important parameters is that no rack or table or any other display or storage apparatus can be in the public right-of-way or blocking an architectural feature (such as a railing, column, etc). Some store fronts have porches so this facilitates the following of this regulation; some store fronts do not have porches so they are not able to do an outdoor merchandise display. Those stores often find other creative means available to them for creating a short-term promotion.

Also no sign can be placed or hung on the merchandise outside. Create a beautiful display of your merchandise without adding an additional sign.
