## **MAYOR'S LETTER**

June is, as usual, a busy month in Occoquan. Our annual spring Arts and Crafts Show takes place on June 7 and 8. As most of you are aware, our fall and spring shows are an important part of the town's revenue base, serving as the primary funding source for our capital projects. Consequently, please attend if you are able, and encourage family and friends to do so as well. On the following Saturday, June 14, Occoquan will once again be the site of the annual Duck Splash Race, when thousands of rubber ducks will drop from one of the town's bridges and race on the river. Prizes range from \$20 to \$500, and all the net proceeds benefit the 501(c)(3) Prince William Trails and Streams Coalition and the Optimist Club of Occoquan, Woodbridge, and Neabsco. You can adopt a duck for \$5 between now and June 14 at selected Occoquan businesses, online at www.pwtsc.org, as well as at the Arts and Crafts Show and on the day of the event.

June is also the month when the Town Council adopts the budget, capital plan, and tax rates for FY 2015. The hearing on the tax rates will take place at 6:30 p.m. on Tuesday, June 17, at Town Hall. Immediately thereafter that same evening, the Town Council will hold a special meeting at which the rates, budget, and capital plan will be formally adopted.

In closing, this is my last monthly newsletter. As you know, I did not seek re-election in May, and consequently my term as your Mayor will formally come to an end on June 30. I would like to take this opportunity to thank all of you – residents, business owners, current and former council members and town staff, as well as friends of Occoquan in the larger community – for your support and fellowship over the past eight years. It has truly been an honor to work with you. Let me also offer my congratulations to Mayor-elect Quist and the incoming Town Council members. You all have my very best wishes.

## At the May 2014 meeting, the Town Council voted to:

• Approve letter of opposition to the plan to install wind turbines on top of the Lorton Landfill;



- Approve the Occoquan Arts and Crafts Show bus contract for the Fall 2014 Arts and Crafts Show;
- Approve Bryan A. Reese as a member of the Town Planning Commission;
- Approve to refer River Park draft zoning district text to Planning Commission to schedule a joint public hearing;
- Approve Rivertown Overlook, Plat Recordation contingent on accomplishing specified requirements;
- Approve the Town to "opt in" to the Virginia Stormwater Management Program;
- Approve to reduce the three sureties currently posted for Occoquan Heights;
- Approve \$1,180 to purchase 20 sets of brackets to complete the banner installation in the Town's historic district;
- Approve \$8,280 for the cost of using law enforcement officers for the Spring Arts and Crafts Show security and traffic detail; and
- Approve setting public hearing dates for May 27, 2014, for the FY 2014-2015 budget, and June 17 for FY 2014-2015 tax rates.

**NOTICE:** The Town Council will hold a public hearing on the FY 2015 proposed tax rates on Tuesday, June 17, at 6:30 pm, at Town Hall. The proposed budget is available on the Town's website at www.occoquan.org or at Town Hall. Town Council will adopt the FY 2015 Budget and tax rates during a special meeting on June 17, following the public hearing.
