MAYOR'S LETTER

A wide variety of events are in the works for the month of April. On Saturday, April 9, from 9:00 a.m. to noon, the Friends of the Occoquan (FOTO) will hold their annual spring river clean-up. This year, the event is again paralleling a larger clean-up that will cover the Occoquan River from the Lake Jackson Dam to the Potomac. Our town is one of the traditional venues for the clean-up, and we have several areas that need particular attention. So, if you are able, please come to Town Hall on the morning of the 9th and donate some time.

Our town farmers' market, organized by the Occoquan Merchants Association (OMA), also kicks off this month on Saturday, April 23. The market is located in the small parking lot at the east end of Mill Street, and will be held every Saturday (except craft show weekends) from 8:00 a.m. to noon through October 29. It took quite some time to get the market started in Occoquan, so please take some time to patronize the market vendors. Also in April, starting on the 22nd, the OMA will launch its ghost tour season. More information on the ghost tours can be found on the OMA website (www.occoquanmerchantsassociation.com). Finally, in April, I will also start once again offering free Saturday kayak and walking historic tours of the town (weather permitting). Kayak tours will leave from the Occoquan Regional Park at 10:00 a.m., and walking tours will leave from the Mill House Museum at 1:00 p.m.

Several meetings of interest to residents and merchants are scheduled for April, as well. At its regular meeting on April 5, the Architectural Review Board (ARB) will once again discuss proposals related to the historic district's sign regulations. We have also tentatively scheduled a public meeting for 7:00 p.m. on April 13 to discuss closing Center Lane and Poplar Alley between Washington and Union Streets to through traffic. Last, Prince William County has released proposed redistricting maps for supervisory districts. These maps are available at www.pwcgov.org/redistricting, and the Board of County Supervisors will be holding a public hearing on redistricting on April 5, at 7:30 p.m., at 1 County Complex Court.
